Remove the cap off the stove

Push the sachet into the opening with the spike to pierce the plastic. Slowly pour the fuel into the funnel. Never use more than one sachet in the stove at a time

Light the stove

Replace the cap to extinguish the flame



Make sure the sachet is empty before throwing away

It is the responsibility of the customer at their own expense to arrange for the stove to be delivered to Nu-Way Clean Energy for repairs and for the collection after the repairs have been made. Should it be found that the damage or fault was a result of the manufacturer, then the stove will be repaired or replaced. The stove or any part that is repaired or replaced during the limited warranty period will be warranted in terms of the original limited warranty of six months.
